| Why? | Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do. |
| What? | The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> • Social Security number and Credit history • Payment history and Account balances • Credit scores and Transaction history |
| How? | All financial companies need to share Customers personal information to run their everyday business. In the section below, we list the reasons financial companies can share their Customers personal information; the reasons First Heritage Mortgage, LLC chooses to share; and whether you can limit this sharing. |

What we do

How does **First Heritage Mortgage, LLC** protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. **We also use procedural safeguards that comply with Federal standards to guard your non-public personal information.**

How does **First Heritage Mortgage, LLC** collect my personal information?

We collect your personal information, for example, when you

- **Apply for a loan** or
- **Provide account information** or
- **Provide employment information** or
- **Give us your contact information** or
- **Give us your wage statements**

We also collect your personal information from other companies

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes — information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone on your account

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Our affiliates include nonfinancial companies such as Stanley Martin Homes, LLC; First Excel Title, LLC; First Excel Title South; Apollo Title Company, LLC; & Lender Service Providers, LLC d/b/a Lenderworks.*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *First Heritage Mortgage, LLC does not share with nonaffiliates so they can market to you.*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Our joint marketing partners include: Keller Williams Metro Center*

Other important information

California residents: In accordance with California law, we will not share information we collect about you with companies outside of our corporation, except as permitted by law, including, for example, with your consent or to service your loan. We will limit sharing among our corporation to the extent required by California law* For the complete California Consumer Privacy Act Notice, please visit our website

Nevada residents: Nevada Statute Section 228.600(3) allows marketing calls to our existing customers listed on the National Do Not Call Registry. If you prefer not to receive marketing calls from us, you may be placed on our Internal Do Not Call List by calling 877-218-8362 or writing to First Heritage Mortgage, LLC at 3201 Jermantown Road, Suite 800, Fairfax, VA 22030. North Dakota residents: In accordance with NDCC section 6-08-1-04, we will not share personal information with non-affiliates either for them to market to you or for joint marketing without your authorization.

Vermont residents: Vermont is an "opt-in" state, and in accordance with state law, we will not share nonpublic personal financial information, credit reports, and/or creditworthiness information about you with other companies unless permitted by law or to service your loan, or unless you specifically consent to share.

OREGON RESIDENTS: First Heritage Mortgage, LLC will not share personal information with non-affiliates for them to market to you without your authorization, and we will not share personal information with affiliates or for joint marketing about your creditworthiness without your authorization.
